D1.6 Report 2-Minutes of project management meetings (M12)

3 Minute

Presentation of WP1 delivered by the coordinator reminded the deliverables submitted (this D1.6 is the next pending one) and provided brief instructions about the schedule set for the next Official Report covering the first years of the project.

WP2 started at the beginning of the previous periodic meeting (held in September 2020) and ran for the next four months (until December 2020).

WP3 a schedule of the next six month period was provided, explaining the current status of the cognitive solutions (CSs) applied to asphalt, steel and pharma.

WP4 status was explained by the WP leader, ENG, presenting the two tasks that have started already and their state of development. The presentation reported also the Deliverables associated to this WP.

Information of WP6 was provided by CORE. T6.2. and T6.3 started at month 8 of the project (November 2020) and will run until the end of it (month 42).

The main topic covered in the Periodic meeting was the official launch of the WP7, that started 1st March 2021. In this part, the leaders of each task have explained the overview of each task, GANTT, PM, Deliverables, and what we should obtain during the develop of this WP.
